January's arrival ushers in familiar routines: colder temperatures, playoff football, and the commencement of new sessions in both the Virginia General Assembly and the US Congress. These seasonal markers offer a comforting sense of normalcy, yet the current political landscape is far from static or normal. Significant changes have swept across Washington D.C., with a new administration and unified government under one party. In Virginia, the fall's statewide elections are expected to cast a long

shadow over the General Assembly's actions.

Both in Richmond and Washington, the

deeply polarized political climate presents

a complex and challenging environment for

effective advocacy.

The recent Virginia and National Political Outlook luncheon underscored the charged political atmosphere at the state and federal levels. It also emphasized the critical importance of proactive engagement by associations and their members. During the luncheon, renowned Virginia political analyst Dr. Bob Holsworth and ASAE's Chief Public Policy and Governance Officer, Mary Kate Cunningham, provided valuable insights into the anticipated key policy battles of the coming year. Beyond specific policy predictions, a crucial takeaway from their remarks was that the evolving political landscape has fundamentally transformed the playing field for associations. The days of relying on established relationships with legislators and staff, and well-worn policy precedents seem over.

The Power of Storytelling

Today's political environment necessitates a more dynamic and proactive approach. Mary Kate Cunningham emphasized the critical need to ensure that our voices are heard loud and clear by those in power. "We must ensure we have a seat at the table, to ensure we're not on the menu at the table." A powerful tool for achieving this is through

storytelling. And what compelling stories associations have to tell!

From healthcare, financial services, transportation, education, energy, environmental protection, and so much more, associations play a vital role in every facet of our daily lives and the overall health of our state and national economies. VSAE member associations are engines of economic development, creating jobs throughout Virginia and contributing significantly to vibrant and sustainable communities. These contributions were rightfully acknowledged by the Governor and the General Assembly last year in honoring VSAE on its 75th anniversary.

Take Action

So, how can you get involved? **ASAE's Legislative Fly-In, scheduled for March 25-26 in Washington D.C.,** presents a unique opportunity for associations to directly engage with legislators and their staff. This event allows associations to highlight the positive contributions their organizations and members make to our state and national economies, as well as their commitment to policies that support a strong and inclusive workforce. It also provides valuable training in association advocacy and equips participants with the necessary tools to build successful policy programs.

With federal tax reform on the agenda in 2025, including proposals to tax the revenue of 501(c)(3) and 501(c)(6) organizations at the 21% corporate tax rate, it is more critical than ever for associations to be at the table and advocate for their interests. Consider joining with other VSAE members as part of the Virginia delegation, meeting with congressional offices to ensure the voices of Virginia's associations are heard on Capitol Hill. Even if you can't attend the Fly-In, ASAE will continue to provide opportunities to share your stories and help make a difference.

Associations have a long and distinguished history of advocating for their members and the issues they care about. By proactively engaging with policymakers and sharing our stories, we can ensure that our voices are heard and that the positive impact of associations continues to be recognized. I encourage you to get involved and help shape a positive future for our associations and the critical missions we serve.



We asked the three Awards of Excellence recipients what advice they would give to someone new to the association industry. Here are their responses:

Stewart Hinkley

I'm coming up on my 33rd anniversary in association management and that's after 10 years in the hotel industry. If you're new to the business and have concerns about whether you've made the right decision, let me try to give you some words of encouragement (and advice).

Our AMC just celebrated its 50th anniversary this year, so we must be doing something right. As I look back at both my career and our company's success, I ask myself what I did well (best practices) and what I would like to do over. Fortunately, the latter isn't a very long list and is mostly attributed to things out of my control.

The bottom line is that I think my success in the association management business is attributed to learning, learning, and learning. There are many ways to learn and I'm talking about beyond your comfort zone. Of course, there is VSAE, which is rich with content and contacts. There is the CAE program. You have tons of online courses and webinars available through ASAE and others. Take some risks and explore.

Get your feet wet with membership, exhibits, meeting planning, graphic design, digital marketing, social media, technology and finances to name a few. Having come from the hotel business, I was strong in meeting planning and exhibits. However, I was weak in membership, graphic design, technology, and finances (social media and digital marketing did not exist). The key for me was surrounding myself with the people who were good at delivering these services. I just had to be willing to learn from them.

Since our AMC has 20 employees who provide these services, all I had to do was walk down the hall and inquire. For example, I had a hard time understanding certain line items on the balance sheet such as "Deferred Dues". How do deferred dues impact the current and next fiscal years' income statements? Fortunately, we have two CPAs on staff who could always answer my questions. I soon gained enough confidence to answer just about any related question in an association board meeting.

If you work for a stand-alone association with just a few staff and you outsource some of the work, you can still learn from these vendors. For example, ask the outsourced graphic designer why it costs more to prepare files for both digital and print media when it's the same newsletter. If your association still has a printed newsletter in addition to a digital, what are the options for blending these efficiently? How much can your association save by eliminating the printed version including graphic design, printing, postage and mail-house handling? If you are asked these questions in your association's board meeting, you might not be able to give the exact answer but just knowing that there would be cost savings in a number of areas would make you look reasonably smart until you could provide the exact figures.

In conclusion, the old saying "you will get out of it what you put into it" is true for association management, so keep learning! You'll know you're there when you are confident and comfortable answering questions in your association's board meeting.

Although my advice sounds redundant, I'd recommend to any member of VSAE to volunteer and get involved.

I have been associated with VSAE for over 40 years going back to my days at Norfolk SCOPE. In the 1980s who would have thought that Rick Eisenman, who was at the Sheraton Oceanfront, and I would both move to Richmond and be so involved with VSAE (of course Rick's involvement is in a different stratosphere than mine), but we have remained close after all of these years.

I am grateful to VSAE for all of the wonderful opportunities it has provided me throughout my career.

Ann Hayes

I have enjoyed being an Associate Member of VSAE. The organization is welcoming and approachable. My advice to a new associate professional member is to learn as much as you can about associations. What I found most useful were the monthly seminars and luncheons hosted by VSAE. These seminars are educational, and the networking afterward is extremely beneficial. Whether you are working with other associates or association professionals, take the time to build those relationships. Getting involved and participating in the Fall Expo and the annual meeting helps you meet other associates who share your questions and can offer advice on how best to work with association executives. The world of associations can change rapidly. Stay on top of trends, best practices, and new technologies by participating in professional development opportunities. Attend events, pursue certifications, and seek mentorship from more experienced professionals.

LET'S RECAP

January Seminar: 2025 Virginia and National Politics

At the January luncheon, Mary Kate Cunningham, Chief Public Policy and Governance Officer at ASAE, discussed ASAE's upcoming March "Fly-In" Congressional lobbying event. ASAE will again advocate for plans to be used toward non-collegiate career training, including apprenticeship and certification programs. ASAE hopes to get this legislation passed in the next tax bill before Congress. She also addressed proposals to tax the non-profit sector, which is currently federal income tax exempt for mission-based endeavors. She urged association leaders to share with legislators the services they will have to stop providing if their organizations are taxed at the 21% corporate rate.

Dr. Bob Holsworth offered his annual assessment of the upcoming General Assembly session and November's gubernatorial elections. He anticipates data centers and their related energy use issues will be emerging topics in the Virginia legislature. Holsworth related how national politics can impact state offices and elections. Virginia may be facing contentious deportation and transgender issues the state really hasn't had to address previously. Looking to the November elections, Abigail Spanberger is the slight favorite to win over Republican Lieutenant Governor Winsome Sears for governor. Rumors are floating that Congressman Bobby Scott might consider running for governor as well. He noted that both parties will have to reckon with who shows up to vote and who doesn't, and how to energize voters to get them to the polls in November.
